- (1) Other than 3,093 shares of Common Stock, which represent Restricted Stock Units granted to the Reporting Person under the Hexcel Corporation 2003 Incentive Stock Plan in his capacity as a director of the issuer (see Footnote 3), the shares reported on this statement were beneficially owned by or through certain affiliated investment entities. The Reporting Person disclaims beneficial ownership of any shares except to the extent of his pecuniary interest therein, if any.
- (2) The conversion rate of the Series A Convertible Preferred Stock is determined using a conversion price initially equal to \$3.00 (subject to adjustment in certain circumstances as provided in the applicable Certificate of Designations). On this basis, each share of Series A Convertible Preferred Stock is convertible into a number of shares of Common Stock equal to \$1000.00/\$3.00.
- (3) Pursuant to an understanding between Mr. Small and Berkshire Partners LLC, Mr. Small holds these shares for the benefit of Berkshire Partners LLC (of which Mr. Small is a member). The Reporting Person disclaims beneficial ownership of these shares except to the extent of his pecuniary interest therein.
