These Common Stock Equivalent Units are payable in cash following the reporting person's retirement or other termination of service.

(4) The number of Common Stock Equivalent Units reported reflect the payment of dividends in the reporting person's account. Common Stock Equivalent Units were acquired pursuant to the MetLife Deferred Compensation Plan for Outside Directors whereby Directors may elect to defer receipt of cash retainer fees into a fund that tracks MetLife, Inc. common stock.
