- (4) This amendment is being filed to correct a clerical error in the reporting of this amount that was off by 2,480 shares on the original filing of the Form 4, but this amount now also reflects a separate gift of 287,260 shares to the Jeffrey Greenberg 2010 GRAT on December 10, 2010 that was not reported on a Form 5 for 2010 until after February 14, 2011, which was the original filing date of the Form 4.
