- On June 15, 2010, the reporting person was granted 200,000 performance share units (PSUs) under the Company's 2008 Incentive Compensation Plan. Each PSU represented a contingent right to receive one share of common stock. As previously reported, on June 16, (1) 2011, the pre-established performance goal for this award was met and 50% of the PSU's vested immediately and were converted into common stock. The remainder vested on June 15, 2012.
