- (1) Includes 40.165 shares acquired through the Home BancShares, Inc. 401(k) Plan since the last filing.

The performance goal will be met as of the end of the calendar quarter when the Company has averaged \$0.3125 diluted earnings per share (split adjusted) for four consecutive quarters or \$1.25 total diluted earnings per share (split adjusted) over a period of four consecutive quarters.
- (7) Restricted Stock granted on February 2, 2011 will vest in 33 1/3% installments over three years each February 2nd.
- (8) Restricted Stock granted on August 2, 2012 will "cliff" vest 100% three years from award date.
