Shares were acquired as the result of the spin off of the Americas Beverages business by Cadbury Schweppes plc, (the "Spin Off") as described in the Reporting Person's Form 4 filed with the SEC on May 9, 2008 (the "Original Filing"). In that Original Filing the Reporting Person reported that he owned 7,810 shares of Common Stock. On January 13, 2011, a Form 5 was filed reporting an (1) additional 500 shares distributed to Reporting Person on the date of Spin Off that were not reported in the Original Filing due to an error made in converting the holdings of these shares. It has been subsequently discovered that an additional 1,433 shares were erroneously not reported in the Original Filing that were transferred into a separate brokerage account at Spin Off. The line item reported in the Original Filing is being corrected to reflect the total number of shares of Common Stock acquired by the Reporting Person at Spin Off.
