- (2) On January 1, 2015, the Reporting Person transferred 562,902 shares of Class B Common Stock to Trust 551-E. No cash consideration was paid in connection with the transfer. The transfer of shares of Class B Common Stock by the Reporting Person constitutes a "permitted transfer" as defined under the Issuer's Amended and Restated Certificate of Incorporation. Accordingly, immediately following the transfer, the shares remain shares of Class B Common Stock.
