Achievement varies from 0% to 120% of target depending on the volume-weighted average price over any consecutive 150-calendar days during the Performance Period as follows: less than \$7.00 = 0% of target, \$7.00 = 25% of target, \$7.50 = 50% of target, \$8.00 = 100% of target, and \$10.00 or greater = 120% of target.
