**Item 1.01 Termination of Stock for Stock Equivalent Exchange Agreement:**

**Croff Enterprises, Inc.** (hereafter **Croff** or the **Company** ) announced today June 1, 2007, that it has terminated its Stock for Stock Equivalent Exchange Agreement with **Taiyuan Rongan Business Trading Company Limited** (hereafter **TRBT** ), based upon the failure of TRBT to timely supply qualifying financial statements to complete the proxy process and to comply with reporting requirements of a public company. Croff did extend the possibility of renewed negotiations with TRBT if accounting issues could be resolved, but the agreement is terminated and no future negotiations are currently contemplated. Attached and incorporated is the termination letter sent from Croff to TRBT. Also attached is the Press Release announcing the termination.
