On November 25, 2013, the Company awarded 7,300 restricted shares under the Company's 2012 Stock Incentive and Award Plan.

(1) One-third of the restricted shares vested on each of November 25, 2014 and 2015, and one-third will vest November 25, 2016. 1,143 of the 2,433 shares that vested November 25, 2015 were withheld to cover withholding taxes due upon vesting. The holdings are net of shares previously withheld, or sold under a Rule 10b5-1 trading plan, to cover withholding taxes.

(2) All such options have fully vested.

On November 28, 2012, the Company awarded 43,000 stock options under the Company's Long-Term Performance Plan. The options

(3) vest in 4 equal annual installments beginning on November 28, 2013. The vested portions of such options will become exercisable upon vesting.

On November 25, 2013, the Company awarded 42,700 stock options under the Company's 2012 Stock Incentive and Award Plan. The

(4) options vest in 4 equal annual installments beginning on November 25, 2014. The vested portions of such options will become exercisable upon vesting.

On November 24, 2014, the Company awarded 49,100 stock options under the Company's 2012 Stock Incentive and Award Plan. The

(5) options vest in 4 equal annual installments beginning on November 24, 2015. The vested portions of such options will become exercisable upon vesting.

On November 23, 2015, the Company awarded 72,800 stock options under the Company's 2012 Stock Incentive and Award Plan. The

(6) options vest in 4 equal annual installments beginning on November 23, 2016. The vested portions of such options will become exercisable upon vesting.
