- (1) On January 13, 2011, the reporting person received a grant of 1,224 shares of restricted stock, which would vest based upon achievement of the actual cumulative Free Cash Flow target at the end of a three-year measuring period. On February 24, 2014, the issuer determined that the performance conditions had not been satisfied and, as a result, the shares were forfeited.
 - (2) On January 12, 2012, the reporting person received a grant of 2,448 shares of restricted stock, 816 of which would vest based upon achievement of specified performance targets at the end of a two-year measuring period. On February 24, 2014, the issuer determined that the performance conditions had been satisfied at 57.1% and, as a result, 350 shares were forfeited and 466 shares vested pursuant to the terms of the grant.
