- Reporting Person has previously reported an indirect interest in 2,379,322 shares (although he disclaimed beneficial ownership in an unspecified number of those shares) held by JMS Group Limited Partnership ("JMS"), a family limited partnership. On July 20, 2010,
- (1) JMS made a pro rata distribution of 548,202 shares to the Mark Lorberbaum Family Perpetual Asset Shield Trust f/b/o Mark Lorberbaum (the "Trust") in connection with a redemption of the limited partnership interest in JMS held by the Trust. Reporting Person is deemed to have a pecuniary interest in the shares held by the Trust.
  - (2) Reporting Person resigned as a member of the general partner of JMS on the distribution date. Thus, Reporting Person no longer has any investment control over the remaining shares held by JMS. Because of the continuing family relationships, Reporting Person may be considered part of a "group" with certain family members; however, Reporting Person disclaims existence of such a "group" and disclaims beneficial ownership of any shares not reported herein.
