**Clarification on sales of downstream assets in Argentina**

Rio de Janeiro, April 08 2010   Petróleo Brasileiro S.A. - Petrobras wishes to clarify about the news published today by the international press regarding the sale of the refinery in San Lorenzo, Argentina, and of other distribution assets.

The Company clarifies that there are negotiations in course for the sale of these assets, but so far no agreement has been established.

Finally, the Company reiterates that it is constantly analyzing business opportunities related to the strategies outlined in its Strategic Plan, and that it will inform the market regarding any material fact, in compliance with the current legislation.
