("Corporate Restructuring"), as previously described in the Material Facts disclosed on September 22, 2015 and March 14, 2016 ("Material Facts").

As disclosed in the Material Facts, the Corporate Restructuring approved did not result in a capital increase or change in ownership of the Company's shareholders, and, therefore, there is no need to talk about exchange ratio of shares or withdrawal rights.
