Common Stock credited to the reporting person if the phantom shares had been invested in FPL Group's company stock fund in its Thrift
- (2) Plan to date. Includes cash dividends that would be payable on the Phantom Shares if the reporting person was the record holder of the number of shares of FPL Group, Inc. Compensation deferred under the Plan is deemed to be invested in a number of unfunded theoretical units equal to the number of units which would have been credited if the deferred compensation had been invested in FPL Group's company stock fund in its Thrift Plan (the Stock Fund). The Stock Fund is accounted for in units of a unitized pool of stock and cash, with the value of each unit determined by reference to the closing price of FPL Group, Inc. Common Stock on the New York Stock Exchange on any given date.

Accounts are payable only in cash at the reporting person's termination of employment with FPL Group, Inc.
