The reporting voluntarily person purchases restricted stock directly from the Company at market price on the last trading day of the month pursuant to an arrangement that was approved by the Compensation Committee of the Company's Board of Directors in a manner (1) that satisfied Exchange Act Rule 16b-3(d). The Company utilizes the net withholding method for each monthly purchase. The reporting person purchased a gross amount of 320 shares of which 101 shares were forfeited to pay withholding taxes associated with the stock issuance.

In connection with the vesting of 7,773 shares on March 30, 2017, a total of 2,454 of such shares were withheld by the Company in order (2) to satisfy the reporting person's tax withholding obligations. The reporting person had no discretion with respect to such sale, which was conducted automatically in accordance with the issuer's corporate policies.

Reflects the weighted average sale price. The range of prices for such transaction is \$8.23 to \$8.26. The reporting person effected multiple (3) same-way open market sale transactions on the same day at different prices through a trade order executed by a broker-dealer.
