Pursuant to the Agreement and Plan of Merger, dated September 30, 2014, among Issuer, News Corporation, and Magpie Merger Sub, (3) Inc., at the effective time of the merger, each outstanding unexercised stock option held by the Reporting Person was assumed by News Corporation and converted into an option to purchase Class A common stock of News Corporation.
