Pursuant to the agreement governing the merger, each Orbotech ordinary share is entitled to receive \$38.86 and 0.25 of a share of KLA-Tencor Corporation common stock, with cash in lieu of a fractional share.
- (2) Received in exchange for 1,666 vested options to purchase Orbotech Ltd. ordinary shares at an exercise price of \$15.57 per ordinary share in connection with the Merger.
- (3) Received in exchange for 5,197 vested options to purchase Orbotech Ltd. ordinary shares at an exercise price of \$27.45 per ordinary share in connection with the Merger.
- (4) Each restricted stock unit ("RSU") represents a contingent right to receive one share of KLA-Tencor common stock.
