(1) 3,681 shares are restricted common stock granted to the reporting person pursuant to issuer's long term incentive compensation plan for employees on June 10, 2013 and vest on June 10, 2016. 3,887 shares are restricted common stock granted to the reporting person pursuant to issuer's long term incentive compensation plan for employees, granted on February 14, 2014 and February 4, 2015. The shares vest ratably over a three-year period on each annual anniversary of the grant.
