Item 1. Description of Registrant's Securities to be Registered.

This Registration Statement relates to the 7.50% Notes due June 10, 2043 (the "Notes") issued by Ford Motor Company (the "Company"). The Notes are described in the Company's Prospectus dated January 24, 2002 (the "Prospectus") under the heading "Description of Debt Securities" and in the Prospectus Supplement (the "Prospectus Supplement") dated June 18, 2003 to the Prospectus under the heading "Description of Notes." The Prospectus Supplement and the Prospectus were filed with the Securities and Exchange Commission pursuant to the Company's Registration Statement No. 333-75214 by the Company pursuant to Rule 424(b)(5) on June 19, 2003.
