The peer group (1) consisted of the Philadelphia Semiconductor Index (SOX) companies as at September 29, 2014, with relative TSR measured over a three year measurement period commencing September 29, 2014. Each PSU is convertible into one share of Kulicke and Soffa Industries Inc. common stock.
