(1) The reported price in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$41.500 to \$41.775, inclusive. (2) On December 22, 2015, the reporting person had 932 shares withheld and cancelled to cover minimum required tax withholdings due to the vesting of restricted stock units. These share cancellations are shown on Table I as dispositions (Transaction Code "D" in Column 4), although none of these cancelled shares were sold into the market, as indicated by Transaction Code "F" in Column 3.
