## Item 2.01 Completion of Acquisition or Disposition of Assets.

As previously disclosed, on June 30, 2014 PPG Industries, Inc. (the "Company") entered into a definitive Stock Purchase Agreement (the "Purchase Agreement") for the acquisition of Consorcio Comex, S.A. de C.V. and its related companies (collectively, "Comex") in a cash transaction valued at \$2.3 billion. On November 5, 2014, the Company completed the acquisition of Comex. On November 5, 2014, the Company issued the press release attached hereto as Exhibit 99, which is incorporated herein by reference.
