 On December 22, 2005, the reporting person filed a Form 4 reporting the acquisition of 12,786 shares of restricted stock that were subject to performance-based vesting conditions that had not yet been achieved. The performance shares should not have been reported until they (1) were earned. The reporting person will file a Form 4 if and when the performance targets are achieved and the shares are earned. As of December 22, 2005, the reporting person owned only 190,545 shares of common stock. Form 4's filed subsequently through February 6, 2007 overstated the shares owned by the reporting person by these shares.
