- (1) The Premium Share Units were acquired under Navistar's Executive Stock Ownership Program. Each Premium Share Unit represents one share of Navistar Common Stock.

  - (3) The restricted stock units became or will become payable in cash in three annual installments as follows: 694 shares on 12/14/2011; 693 shares on 12/14/2012 and 693 shares on 12/14/2013.
