Item 1.01 Entry into a Material Definitive Agreement.

On June 25, 2007, Flexsteel Industries, Inc. (the Company) entered into agreements amending the maturity dates of its primary credit facilities. The amended agreements extend the maturity date for the \$20 million long-term facility from October 31, 2010 to September 30, 2012 and the maturity date for the short-term \$20 million facility from June 29, 2007 to June 30, 2008. The other terms of the credit facility agreements remained unchanged.
