Mr. Sampson beneficially owns 1,076,854 shares of the outstanding common stock of the Issuer, which includes:

- (i) 587,149 shares of common stock owned by Mr. Sampson individually;
- (ii) options to purchase 9,000 shares of common stock held by Mr. Sampson and exercisable within 60 days of December 31, 2013;
- (iii) 7,737 shares of restricted stock subject to restrictions on resale until May 21, 2015;
- (iv) 43,354 shares of the Issuer held by Mr. Sampson through the Communications Systems, Inc. Employee Stock Ownership Plan (“CSI ESOP”);
- (a) (v) 24,614 shares owned by Mr. Sampson’s spouse;
- (vi) 7,000 shares held by the Sampson Family 2008 Irrevocable Trust; and
- (vii) 398,000 shares held by the Curtis A. Sampson 2012 Family Irrevocable Trust. Mr. Sampson serves as a trustee of the two trusts described above, which were established for the benefit of Mr. Sampson’s children and grandchildren.

Mr. Sampson is also a trustee of the CSI ESOP. As of December 31, 2013, the CSI ESOP held 560,862 shares of the Issuer. Mr. Sampson disclaims any beneficial ownership of the shares of the Issuer owned by his spouse and the trusts for the benefit of his children and grandchildren and disclaims beneficial ownership of any shares of the Issuer held by the CSI ESOP in excess of the shares 43,354 allocated to his individual CSI ESOP account.

12.6% based on 8,551,542 shares of the Issuer’s common stock outstanding as reported in the Issuer’s Form 10-Q filed November 8, 2013 and including all 1,076,854 shares that could be deemed to be beneficially owned by Mr. Sampson. If all shares held by the CSI ESOP allocated to accounts other than that of Mr. Sampson were included in the number of shares beneficially owned by Mr. Sampson, Mr. Sampson would be
