Glenview Capital Management serves as investment manager to each of Glenview Capital Partners, Glenview Capital Master Fund, Glenview Institutional Partners, Glenview Offshore Opportunity Master Fund, Glenview Capital Opportunity Fund, GCM Master Fund and the Managed Account. Mr. Robbins is the Chief Executive Officer of Glenview Capital Management.

This amount consists of: (A) 208,054 Shares held for the account of Glenview Capital Partners; (B) 2,556,338 Shares held for the account of Glenview Capital Master Fund; (C) 813,461 Shares held for the account of Glenview Institutional Partners; (D) 2,236,264 Shares held for the account of Glenview Offshore Opportunity Master Fund; (E) 1,848,345 Shares held for the account of Glenview Capital Opportunity Fund; (F) 523,027 Shares held for the account of GCM Master Fund; and (G) 727,365 Shares held for the Managed Account.
