(1) Mr. Ben Farahi owns an additional 599,216 shares (594,616 shares following the sales reported on this Form 4) of shared voting power common stock of Monarch Casino & Resort, Inc. ("Monarch") listed under the Jila Farahi Trust. Mr. Ben Farahi is a trustee of the Jila Farahi Trust. Jila Farahi is the sister of Mr. Ben Farahi but is not a director, officer or 10% owner of Monarch.

(2) On October 21, 2004, Mr. Farahi was granted an option pursuant to the Company's 1993 Executive Long-Term Incentive Plan, as amended, to purchase 50,000 shares of the Company's common stock at \$23.37 per share. The shares will vest as follows: 16,666 shares on October 21, 2005; 16,666 shares on October 21, 2006; 16,667 shares on October 21, 2007.
