Under the terms of the plan, the fair market value of any fractional share of Common Stock not used to satisfy the withholding obligation will be paid in cash at the time the RSU's are settled.

 - (3) The restricted stock units vest in four equal annual installments beginning on February 14, 2009.
 - (4) The option vests in four equal annual installments beginning on February 11, 2011.
