Before joining BIC Group, McGarvie was chief financial officer for a Fortune 500 company, Hannaford Bros. Co., acquired in 1999 by Delhaize Group.

She currently serves on the Boards of Directors of Accenture, Viacom, Wawa, Inc., and LKQ Corp., and previously served on the boards of The Travelers Companies, Inc., Pepsi Bottling Group and Lafarge North America.

McGarvie has been appointed to serve on the Financial Policy and Employee and Public Responsibility Committees of the Board.

There are no family relationships between Ms. McGarvie and any other executive officer or director of the Company, and there are no arrangements or understandings pursuant to which she has been appointed.
