DTE Energy Company (“DTE Energy”) will meet with investors at the Barclays Energy Conference on September 9-10, 2015. DTE Energy Sr. Vice President and Chief Financial Officer Peter B. Oleksiak will provide a business update at the conference at 7:45 a.m. EDT September 10, 2015. In the meetings and in the slide presentation, DTE Energy reaffirms its 2015 operating earnings per share guidance of \$4.54-\$4.90 per share.

In its slide presentation and this filing, DTE Energy discusses 2015 operating earnings guidance. It is likely that certain items that impact the company's 2015 reported results will be excluded from operating results. Reconciliations to the comparable 2015 reported earnings guidance are not provided because it is not possible to provide a reliable forecast of specific line items. These items may fluctuate significantly from period to period and may have a significant impact on reported earnings.
