- Mr. Eppinger "net exercised" 80,000 options. The options were granted to Mr. Eppinger in 2003 when he joined the Company, and were
- (1) scheduled to expire in August 2013. A total of 60,771 shares were withheld by the Company to satisfy the exercise price and taxes associated with the exercise, resulting in the net issuance of 19,229 shares to, and held by, Mr. Eppinger.
 - (2) Does not include 160,362 shares held indirectly in a Rabbi Trust pursuant to deferral agreements.
 - (3) Such options vested 25% on each of the first two anniversaries of the grant date and 50% on the third anniversary of the grant date.
