Item 1. <u>Description of Registrant</u> s <u>Securities to be Registered</u>.

On November 5, 2009, the Board of Directors of CA, Inc. (the <u>Company</u>) adopted the Stockholder Protection Rights Agreement (the <u>New Rights Agreement</u>) between the Company and Mellon Investor Services LLC, as Rights Agent (the <u>Rights Agent</u>), and declared a dividend of one right (<u>a</u> Right) for each outstanding share of Common Stock, par value \$0.10 per share (<u>Common Stock</u>) of the Company held of record at the close of business on November 16, 2009 (the <u>Record Time</u>), payable in respect of each such share upon the later of (i) certification by The NASDAQ Stock Market LLC to the Securities and Exchange Commission that the Rights have been approved for listing and registration and (ii) immediately following the expiration of the Existing Rights Agreement (as defined in the New Rights Agreement) (the <u>Payment Time</u>), or issued thereafter and prior to the Separation Time (as defined in the New Rights Agreement) and thereafter pursuant to options and convertible securities outstanding at the Separation Time.

The New Rights Agreement (which includes as Exhibit A the forms of Rights Certificate and Election to Exercise and as Exhibit B the form of Certificate of Designations and Terms of the Participating Preferred Stock) is attached hereto as an exhibit and is hereby incorporated herein by reference. The description of the New Rights Agreement and the Rights is incorporated by reference herein to the Company s Current Report on Form 8-K, filed with the Securities and Exchange Commission on November 5, 2009, and is qualified in its entirety by reference to the New Rights Agreement and all exhibits thereto.
