ITEM 5. OTHER EVENTS.

On July 12, 2002, Trump's Castle Associates, L.P. ("Trump's Castle"), a wholly-owned subsidiary of Trump Hotels & Casino Resorts, Inc. (NYSE: DJT) and the owner and operator of Trump Marina Hotel Casino in Atlantic City, New Jersey, redeemed the entire \$62.0 million principal amount of Trump's Castle Funding, Inc.'s 10-1/4% Senior Secured Notes due April 30, 2003 and \$5.0 million principal amount of Trump's Castle Hotel & Casino, Inc.'s 10-1/4% Working Capital Loan due April 30, 2003 utilizing the net proceeds of Trump's Castle's \$70.0 million term credit facility entered into on June 12, 2002, as previously disclosed.
