This Registration Statement registers additional shares of the Common Stock of Intevac, Inc. (the *Registrant*) to be issued pursuant to the Registrant's 2004 Equity Incentive Plan. - (2) That for the purpose of determining any liability under the 1933 Act each such post-effective amendment shall be deemed to be a new registration statement relating to the securities offered therein and the offering of such securities at that time shall be deemed to be the initial bona fide offering thereof and
- (3) To remove from registration by means of a post-effective amendment any of the securities being registered which remain unsold at the termination of the Registrant's 2004 Equity Incentive Plan.
