As of the close of business on November 16, 2015, 683 Capital Partners, LP directly owned \$7,525,000 aggregate principal amount of 7.50% Convertible Senior Secured Notes due 2022 (the "Notes") initially convertible into 11.7114 shares of Common Stock per \$1,000 principal amount of Notes, subject to adjustment.

As of the close of business on November 16, 2015, 683 Capital Partners, LP may be deemed to have beneficially owned 88,128 shares of Common Stock issuable upon the conversion of the aggregate principal amount of Notes directly owned by it, in addition to 1,107,833 shares of Common Stock directly owned by it.

683 Capital Management, LLC, as the Investment Advisor of 683 Capital Partners, LP, may be deemed to have beneficially owned the 1,195,961 shares of Common Stock beneficially owned by 683 Capital Partners, LP.

Ari Zweiman, as the Managing Member of 683 Capital Management, LLC, may be deemed to have beneficially owned the 1,195,961 shares of Common Stock beneficially owned by 683 Capital Management, LLC.

The following percentage is based on 16,948,932 shares of Common Stock outstanding as of October 28, 2015, as reported in the Issuer's Amendment to the Quarterly Report on Form 10-Q filed with the Securities and Exchange Commission on November 10, 2015 plus an aggregate of 1,107,833 shares of Common Stock issued upon conversion of Notes previously owned by the Reporting Persons.

As of the close of business on November 16, 2015, each of the Reporting Persons may be deemed to have beneficially owned approximately 6.6% of the outstanding shares of Common Stock.
