#### Item 1.01 Entry into a Material Definitive Agreement.

On September 6, 2006, the Registrant and National Financial Communications Corp. (the "Consultant") amended an existing consulting agreement dated as of May 1, 2006 (the "Consulting Agreement", as amended, the "Amendment").
