The registrant hereby amends this registration statement on such date or dates as may be necessary to delay its effective date until the registrant shall file a further amendment which specifically states that this registration statement shall thereafter become effective in accordance with section 8(a) of the Securities Act of 1933 or until the registration statement shall become effective on such date as the Commission, acting pursuant to said section 8(a), may determine.

On July 22, 1997, Microsoft Corporation (Microsoft) filed a Registration Statement on Form S-3, SEC 1933 Act Number 333-31803 (the Registration Statement) covering 154,898¹ shares of Microsoft s common stock (the Common Stock) on behalf of certain Selling Shareholders of Microsoft.

The Registration Statement was filed in order to register shares of Common Stock issued to former shareholders of Dimension X and Cooper & Peters, Inc. (Dimension X and Cooper & Peters, respectively). Microsoft acquired Dimension X on May 14, 1997 and Cooper & Peters on June 11, 1997.

Pursuant to the terms of the Agreements and Plans of Reorganization between Microsoft and certain former shareholders of Dimension X and Cooper & Peters, Microsoft s obligations to maintain the effectiveness of the Registration Statement expired on May 14, 1999 and June 11, 1999, respectively. Accordingly, Microsoft hereby de-registers all of its Common Stock registered pursuant to the Registration Statement and remaining unsold thereunder.

¹ Represents 619,592 shares of Common Stock after taking into account the two-for-one stock splits effected by Microsoft on February 20, 1998 and March 26, 1999.
