- (c) During the last five years, Mr. Kidron has not been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanours).
- (d) During the last five years, Mr. Kidron was not a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.
- (e) Mr. Kidron is an Israeli citizen.

### **Item 3. Source and Amount of Funds or Other Considerations**

Pursuant to a Private Placement dated March 3, 2006, the Issuer issued 10,371,735 common shares of the Issuer to Mr. Kidron.

### **Item 4. Purpose of Transaction**

Mr. Kidron entered into the March 3, 2006 transaction and acquired the 10,371,735 common shares for investment purposes, but may transfer or sell such shares as necessary and in accordance with applicable securities laws.

Mr. Kidron does not presently have any plan or proposal which relate to or would result in any of the following: the acquisition or disposition by any person of additional securities of the Issuer; an extraordinary corporate transaction involving the Issuer or its subsidiaries; a sale or transfer of a material amount of the Issuer's or its subsidiaries' assets; any material change in the present capitalization or dividend policy of the Issuer; any other

material change in the Issuer's corporate structure; any changes to the Issuer's charter, bylaws or instruments corresponding thereto which may impede the acquisition of control by any person; causing a class of securities of the Issuer to be delisted from a national securities exchange or cease to be authorized to be quoted in an inter-dealer quotation system of a registered national securities association; or a class of equity securities of the Issuer becoming eligible for termination of registration pursuant to section 12(g)(4) of the Securities Exchange Act of 1934.

### **Item 5. Interest in Securities of the Issuer**

The aggregate number and percentage of common shares of the Issuer beneficially owned by Mr. Kidron is 10,371,735 common shares, or approximately 25% of the Issuer, based on 41,456,779 common shares outstanding.

Mr. Kidron has the sole power to vote or direct the vote, and to dispose or direct the disposition, of 10,371,735 shares of common stock of the Issuer.

Other than as described in Item 3 above, Mr. Kidron has not effected any transaction in the shares of common stock of the Issuer in the past sixty days.

No person, other than Mr. Kidron, is known to have the right to receive or the power to direct the receipt of dividends from, or the proceeds from the sale of, the 10,371,735 shares of common stock of the Issuer.
