We have received a letter from your general counsel informing us that you have purchased 100 shares of our stock and making a demand that we provide you with a list of CF Industries stockholders in order to communicate with them. We want to give you the opportunity to explain to the Terra stockholders, and to us, why you appear to be more interested in communicating with our stockholders than in negotiating a merger

agreement with us. We also note that, although your by-laws require you to hold your annual meeting no later than May 15, you have not announced the time and place of your meeting. We would appreciate an explanation as to why you have not yet announced your meeting arrangements.

As you are aware from our interactions over the years, including our meeting in February, we and our advisors are prepared to meet with you and your advisors to negotiate promptly in good faith a merger agreement between our two companies. We continue to believe in the compelling strategic logic of such a combination structured in a manner that allows all of our respective stockholders to share in the future benefits of the transaction. We believe that Terra stockholders share our view and we do not understand your reluctance to explore this opportunity in direct discussions.

CF Industries, Inc. is a major producer and distributor of nitrogen and phosphate fertilizer products. The Registration Statement has not yet become effective. The Offer is made only through the Exchange Offer Documents. Information regarding CF Industries' directors and executive officers is available in the supplement to its proxy statement for its 2009 annual meeting of stockholders, which was filed with the SEC on April 7, 2009, and a description of their direct and indirect interests in such solicitation, by security holdings or otherwise, will be contained in the proxy statement/prospectus filed in connection with the proposed transaction with Terra.
