The description of the Credit Agreement Amendment under Item 2.03 below is incorporated in this Item 1.01 by reference.

Item 2.03. Creation of a Direct Financial Obligation or an Obligation under an Off-Balance Sheet Arrangement of a Registrant

On December 8, 2014, Envestnet and certain of its subsidiaries entered into a first amendment to credit agreement (the Credit Agreement Amendment) amending the credit agreement, dated June 19, 2014 (as amended, the Credit Agreement), with a group of banks (the Banks), for which Bank of Montreal, a Canadian chartered bank acting through its Chicago branch, is acting as administrative agent. Pursuant to the Credit Agreement Amendment, the amount of the unsecured revolving credit facility was increased from \$70 million to \$100 million with a sublimit for the issuance of letters of credit of \$5 million. Subject to certain conditions, Envestnet has the right to increase the facility by up to \$25 million. The Credit Agreement is scheduled to mature on December 8, 2017. As of December 8, 2014, there was \$30 million of indebtedness under the Credit Agreement outstanding.

Borrowings under the Credit Agreement will be guaranteed by substantially all of Envestnet s U.S. subsidiaries. Proceeds under the Credit Agreement may be used to finance capital expenditures, to finance working capital, to finance permitted acquisitions and for general corporate purposes.

There is no material relationship between Envestnet or any of its subsidiaries or affiliates and Bank of Montreal, other than in respect of the Credit Agreement and certain commercial and investment banking relationships, all of which have been entered into in the ordinary course of business.

The foregoing description of the Credit Agreement Amendment does not purport to be complete and is qualified in its entirety by reference to the Credit Agreement Amendment, a copy of which is attached as Exhibit 10.1 and incorporated herein by reference.
