- (1) Filer elected to receive restricted stock units in lieu of cash compensation.

- (3) Each restricted stock unit ("RSU") has the economic equivalent of one share of CIT common stock.
- (4) RSUs are scheduled to vest in three equal installments on May 15, 2019, 2020, and 2021 and are payable 50% in shares of CIT common stock and 50% in cash. The cash payment shall be based on the closing price of CIT common stock on the vesting date.
- (5) Filer elected to defer issuance of stock until no longer a member of the Board.
- (6) Filer elected to receive 100% stock upon settlement.
