- (1) Includes 682 shares purchased on January 31, 2011 under the Employee Stock Purchase Plan at \$10.9905 per share. Excludes 61,120 Performance Unit Shares and 22,000 Performance Shares previously reported on Mr. Mosley's Form 4 dated September 15, 2010. The vesting of these awards remain subject to the achievement of performance goals that are not tied to the market price of the Company's ordinary shares. Pursuant to the Securities and Exchange Commission's interpretative guidance, these Performance Unit Shares and Performance Shares are not required to be reported on Mr. Mosley's Section 16 filings until such performance goals have been achieved.
- (3) The Sale reported on this Form 4 was affected by a 10b5-1 trading plan adopted by the Reporting Person on February 22, 2011.
