

On November 15, 2011, BankFinancial Corporation (the Company) announced that its Board of Directors has extended the expiration date of the Company's current share repurchase authorization from November 15, 2011 until May 15, 2012, subject to the requirement that any share repurchases conducted pursuant to such authorization must comply with any applicable requirements of Federal Reserve Board Supervisory Letter SR 09-4.

As of November 15, 2011, the Company had repurchased 4,239,134 shares of its common stock out of the 5,047,423 shares that had been previously authorized for repurchase.

As previously disclosed, the authorization permits shares to be repurchased in open market or negotiated transactions, and pursuant to any trading plan that may be adopted in accordance with Rule 10b5-1 of the Securities and Exchange Commission. The authorization will be utilized at management s discretion, subject to the limitations set forth in Rule 10b-18 of the Securities and Exchange Commission and other applicable legal requirements, and to price and other internal limitations established by the Board of Directors. The authorization may be suspended, terminated or modified at any time prior to May 15, 2012 for any reason, including, without limitation, market conditions, the cost of repurchasing shares, the availability of alternative investment opportunities, liquidity, and other factors deemed appropriate. These factors could also affect the timing and amount of any share repurchases.
