**ITEM 1.01 ENTRY INTO A MATERIAL AGREEMENT**

On January 7, 2013, Kilroy Realty, L.P. (the Operating Partnership ) and Kilroy Realty Corporation (the Company ) entered into an underwriting agreement (the Underwriting Agreement ) with J.P. Morgan Securities LLC ( J.P. Morgan ), Barclays Capital Inc. ( Barclays ), Merrill Lynch, Pierce, Fenner & Smith Incorporated ( BofA Merrill Lynch ) and Wells Fargo Securities, LLC ( Wells Fargo Securities ).

Under the Underwriting Agreement, J.P. Morgan, Barclays, BofA Merrill Lynch and Wells Fargo Securities agreed to serve as representatives of the several underwriters listed on Schedule A attached to the Underwriting Agreement in connection with the public offering by the Operating Partnership of \$300.0 million aggregate principal amount of the Operating Partnership's 3.800% Senior Notes due 2023. The notes will be guaranteed by the Company.

The foregoing description of the Underwriting Agreement does not purport to be complete and is qualified in its entirety by the full text of the Underwriting Agreement, which is being filed as Exhibit 1.1 to this Current Report on Form 8-K and is incorporated herein by reference.
