(NYSE: MDT) (the Company) confirms that, at the close of business on 28 November, 2014, its issued share capital is comprised of 984,507,885 shares of common stock having a par value of \$0.10 each (the Common Stock). The Company also confirms that, at the close of business on 28 November, 2014, there were 9,640,978 restricted stock shares and units with respect to the Common Stock, and 30,164,311 options to purchase Common Stock which are currently outstanding.
