**Item 1. Description of Registrant's Securities to be Registered.**

The securities to be registered hereby are the 74,000,000 depository shares (the "Depository Shares"), each representing a 1/400<sup>th</sup> interest in a share of JPMorgan Chase & Co.'s 6.00% Non-Cumulative Preferred Stock, Series EE, \$1 par value and with a liquidation preference of \$10,000 per share (equivalent to \$25 per depository share) (the "Preferred Stock"). The terms of the Preferred Stock and the Depository Shares are described in the prospectus, dated April 15, 2016, under the captions "Description of the Preferred Stock" and "Description of the Depository Shares," as supplemented by the prospectus supplement, dated January 16, 2019 (together, the "Prospectus"). Such information, as it may hereafter be amended or supplemented and filed as part of an amendment to the Registration Statement on Form S-3 (File No. 333-209681) of which the Prospectus forms a part or otherwise pursuant to Rule 424(b) under the Securities Act of 1933, as amended, is hereby incorporated by reference.
