(1) Represents a grant of restricted stock awards (RSUs) granted by the Company on August 26, 2011. If the performance criteria of the RSUs are met, the RSUs will vest on August 26, 2014. Additional terms apply in the event of the holder's termination, death, disability or retirement.

(2) The Stock Appreciation Rights (SARs) were issued at the closing price of the Company's stock on August 26, 2011 (\$28.76). They will vest in equal amounts over three years and will expire ten years after the grant date. Upon exercise, the holder will receive in Belden stock the excess of fair market value per share at the time of exercise over the exercise price, times the number of SARs being exercised. Additional terms apply in the event of the holder's termination, death, disability or retirement.
