#### INTRODUCTION

Belden Inc. (the "Company") files this registration statement on Form S-8 to register 200,000 shares of its common stock for issuance pursuant to the Belden Wire & Cable Company Retirement Savings Plan (as amended pursuant to the amendment included in this registration statement as Exhibit 4.7, the "Plan"). This registration statement covers the registration of the Company's common stock that may be issued in the event Plan participants were to elect, in accordance with and subject to the provisions of the Plan, to purchase Company shares in the Company stock fund from another investment fund of the Plan.

#### PART I

## INFORMATION REQUIRED IN THE SECTION 10(a) PROSPECTUS

The Company will send or give to employees (as specified by Rule 428(b)(1) of the Securities Act of 1993, the "Act") the documents containing the information specified in Part I of Form S-8 (i.e., plan information and registrant information). Such documents need not be filed with the Securities and Exchange Commission ("Commission") either as part of this Registration Statement or as a prospectus or prospectus supplements pursuant to Rule 424 of the Act. These documents (including the statement of availability required by Item 2 of Form S-8) and the documents incorporated by reference in this Registration Statement pursuant to Item 3 of Form S-8 (Part II hereof), taken together, constitute a prospectus that meets the requirements of Section 10(a) of the Act.

## PART II

## INFORMATION REQUIRED IN THE REGISTRATION STATEMENT

## ITEM 3. INCORPORATION OF DOCUMENTS BY REFERENCE.

The following documents, which the Company has filed with the Commission, are incorporated herein by reference:

- (a) the Company's Annual Report on Form 10-K for the fiscal year ended December 31, 2002;
- (b) all other reports filed by the Company pursuant to Section 13(a) or 15(d) of the Securities Exchange Act of 1934 (the "Exchange Act") since the fiscal year ended December 31, 2002; and
- the description of the Company's common stock incorporated by reference in the Registration Statement on Form 8-A for the registration of the common stock of the Company pursuant to Section 12(b) or (g) of the Securities Exchange Act of 1934, as amended (the "Exchange Act") filed with the Commission on August 25, 1993, including any amendment or report filed for the purpose of updating such description.

All documents subsequently filed by the Company pursuant to Sections 13(a), 13(c), 14 and 15(d) of the Exchange Act, prior to the filing of a post-effective amendment which indicates that all securities offered hereby have been sold or which deregisters all securities then remaining unsold, shall be deemed to be incorporated by reference herein and to be part hereof from the

date of filing of such documents.

#### ITEM 4. DESCRIPTION OF SECURITIES.

The Company's common stock, par value \$.01 per share, is registered pursuant to Section 12 of the Exchange Act, and therefore the description of securities is omitted.

#### ITEM 5. INTERESTS OF NAMED EXPERTS AND COUNSEL.

Kevin Bloomfield (whose opinion is contained in Exhibit 5.1) owns shares of the Company's common stock, holds options to purchase shares of such common stock, and participates in the Company's employee benefit plans.

#### ITEM 6. INDEMNIFICATION OF DIRECTORS AND OFFICERS.

Section 145 of the General Corporation Law of the State of Delaware ("GCL") provides that a Delaware corporation may indemnify any person against expenses, judgments, fines and amounts paid in settlements actually and reasonably incurred by any such person in connection with a threatened, pending or completed action, suit or proceeding, (other than an action, suit or proceeding in the name of the corporation), in which he is involved by reason of the fact that he is or was a director, officer, employee or agent of such corporation, provided that (i) he acted in good faith and in a manner he reasonably believed to be in or not opposed to the best interests of the corporation and (ii) with respect to any criminal action or proceeding, he had no reasonable cause to believe his conduct was unlawful.

If the action or suit is by or in the name of the corporation, the corporation may indemnify any such person against expenses actually and reasonably incurred by him in connection with the defense or settlement of such action or suit if he acted in good faith and in a manner he reasonably believed to be in or not opposed to the best interests of the corporation, except that no indemnification may be made in respect to any claim, issue or matter as to which such person shall have been adjudged to be liable to the corporation, unless and only to the extent that the Delaware Court of Chancery or the court in which the action or suit is brought determines upon application that, despite the adjudication of the liability but in light of the circumstances of the case, such person is fairly and reasonably entitled to indemnity for such expense as the court deems proper.

The Certificate of Incorporation of the Company provides indemnification to directors and officers of the Company to the fullest extent permitted by the GCL.

In accordance with Section 102(b)(7) of the GCL, the Certificate of Incorporation of the Company eliminates each director's liability to the Company or its stockholders for monetary damages except (i) for any breach of the director's duty of loyalty to the Company or its stockholders, (ii) for acts or omissions not in good faith or which involve intentional misconduct or a

knowing violation of law, (iii) under the section of the Delaware law providing for liability of directors for unlawful payment of dividends or unlawful stock purchases or redemptions, or (iv) for any transaction from which a director derived an improper personal benefit. The effect of this provision is to eliminate the personal liability of directors for monetary damages for actions involving a breach of their fiduciary duty of care.

The Company has obtained a directors' and officers' liability insurance

policy, which insures the Company's directors and officers against certain liabilities, including liabilities for which the Company may not be able to indemnify such persons. The Company has also entered into indemnification agreements with each director and executive officer, which provide for indemnification against expenses, judgments, fines and settlements in connection with threatened or pending litigation, inquiries or investigations that arise out of the director's or officer's acts or omissions in his capacity as a director or officer of the Company to the extent permitted by Delaware law.

Insofar as indemnification for liabilities arising under the Act may be permitted to directors, officers or persons controlling the Company pursuant to the foregoing provisions, the Company has been informed that in the opinion of the Commission such indemnification is against public policy as expressed in the Act and is therefore unenforceable.

Insofar as indemnification for liabilities arising under the Securities Act of 1933 may be permitted to directors, officers and controlling persons of the registrant pursuant to the foregoing provisions, or otherwise, the registrant has been advised that in the opinion of the Securities and Exchange Commission such indemnification is against public policy as expressed in the Act and is, therefore, unenforceable. In the event that a claim for indemnification against such liabilities (other than the payment by the registrant of expenses incurred or paid by a director, officer or controlling person of the registrant in the successful defense of any action, suit or proceeding) is asserted by such director, officer or controlling person in connection with the securities being registered, the registrant will, unless in the opinion of its counsel the matter has been settled by controlling precedent, submit to a court of appropriate jurisdiction the question whether such indemnification by it is against public policy as expressed in the Act and will be governed by the final adjudication of such issue.
